SHOWCASING PRODUCT CATALOGUE Swiggy testing platform that enables D2C brands

FOODTECH AND HYPER-LOCAL delivery unicorn Swiggy is working on an e-commerce discovery platform for direct-to-consumer (D2C) brands. The platform will allow brands and manufacturers to display a catalogue of products within the Swiggy app, a person aware of the development said. Dubbed 'Minis', the online discovery platform will allow D2C brands to find new distribution via Swiggy's already existing large consumer base. "The new platform is yet to be released for public users, and the company is planning on a larger pilot testing in the coming months. Currently, it is only available internally for Swiggy employees for beta testing," a source said. A spokesperson for Swiggy confirmed that it has already started working internally on the 'Minis' discovery platform. "We are continuously experimenting

with ways in which we can delight our customers and enable our brand partners to succeed. We're currently piloting a platform named Minis on Swiggy that enables D2C brands, small businesses and individual entrepreneurs to showcase their offerings directly to lakhs of customers," the spokesperson said in a statement. The source mentioned earlier also said that Swiggy has already begun working with a few brands in the D2C space, including categories like clothing and accessories,

among others. The D2C space has witnessed an increased interest from investors over the last few years due to its ability to compete well with large FMCG market leaders by undercutting prices and focusing on niche categories. Some analysts estimated that the size of the D2C market in India will cross the \$100-billion mark by 2025. In India, D2C brands across beverages, clothing, fashion and consumer electronics have witnessed strong market recall among consumers.

Adani: Ukraine war exposed overswing on green tech

RICHEST INDIAN GAUTAM Adani has said the world's headlong rush into "nascent" green energy solutions has undergone a correction after the ongoing war in Ukraine forced countries to scramble for fossil fuel supplies. "Very few are willing to admit that there had been an overswing on the side of green solutions and technologies that were still in their nascent stage," Adani wrote in a May 26 LinkedIn note after attending the World Economic Forum in Davos. "This fragility has been totally exposed by the crisis in Ukraine." Better sense may now prevail around "what pragmatic energy transitions might look like as opposed to green transitions based on little more than magical thinking," he said. He also called out the developed nations for "setting targets and giving stern lectures about climate change to the rest of the world". Adani said the Davos meeting this year was heavily skewed towards border security and self-reliance in defence capabilities.

Myntra launches 48-hour delivery service

WALMART-OWNED MYNTRA on Thursday introduced an express delivery feature called M-Express which will allow shoppers to receive their orders within 24-48 hours of purchase, the fashion e-commerce portal said. This expedited delivery feature will be applicable across 300,000 styles and will service over 1,300 pin codes, through Myntra's delivery network. The company will expand to tier 2 and 3 cities, as well as launch the web version of the feature.

परशुराम घाटातील वाहतूक २४ तास सुरू

रत्नागिरी, दि.२६ : मुंबई-गोवा राष्ट्रीय महामार्गावरील परशुराम घाटातील दररोज दुपारचा मेगाब्लॉक बंद करण्यात आला असून आजपासून घाटातून २४ तास वाहतूक सुरू झाली आहे. परशुराम घाटातील धोकादायक भागातील काम करण्यासाठी जिल्हाधिकार्यांच्या आदेशानंतर हा घाट एप्रिलपासून कालपर्यंत (दि. २५ मे) दररोज सहा तास वाहतूकीसाठी बंद

ठेवण्यात आला होता. हा मेगाब्लॉक आजपासून बंद करण्यात आला असून परशुराम घाटातून तास वाहतूक खूला करण्यात आली आहे. त्यामुळे मुंबई-गोवा महामार्गावरील जिल्हाभरातील एसटी आणि इतर वाहतूक सुरळित झाली आहे. चिपळूणनजीकच्या परशुराम घाटातील धोकादायक भागातील चौपदरीकरणचे काम मार्गी लागते म्हणून ठेकेदार कंपन्यांशी चर्चा

करून जिल्हाधिकार्यांनी परशुराम घाट दररोज दुपारी १२ ते सायंकाळी ६ पर्यंत बंद ठेवण्याचा निर्णय घेतला होता. या कालावधीत ७०० मीटर लांबीच्या एका मागिकेचे कॉन्क्रीटकरण पूर्ण करण्यात यश आले असून येत्या १५ जूनपर्यंत आणखी ३०० मीटरचे कॉन्क्रीटकरण पूर्ण करण्यात येईल, असे राष्ट्रीय महामार्ग विभागाकडून सांगण्यात येत आहे. परशुराम घाटातील वाहतूक दररोज

सहा तास बंद ठेवली जात असल्याने एसटी महामंडळाने जिल्हातील या महामार्गावरून जाणारी एसटी सेवा दुपारच्या वेळेत रद्द केली होती. दुपारी १२ ते सायंकाळी ६ दरम्यान सुटण्याचा गाड्या बंद होत्या. मात्र आता एसटीचे वेळापत्रक नियमितपणे सुरू होणार असून मुंबई-गोवा महामार्गावरून सर्व आगारातून सुटण्याचा गाड्या नियोजित वेळेत सुटणार आहेत.
